#### Location

The unit is strategically located on the well-established Chainbridge Road, offering great connectivity situated 1 mile from the A1. The unit comprises of steel portal frame construction with clad elevations, blockwork walls and pitched trussed insulated double skin roof. The property benefits from office space which leads into the warehouse which consists of strip LED lighting, carpets, gas central heating, both male and female WC's, tea point and a reception at main pedestrian entrance to the unit. Access to the warehouse is facilitated by 2 electric roller shutter doors measuring 4.2m wide by 4.6m high.

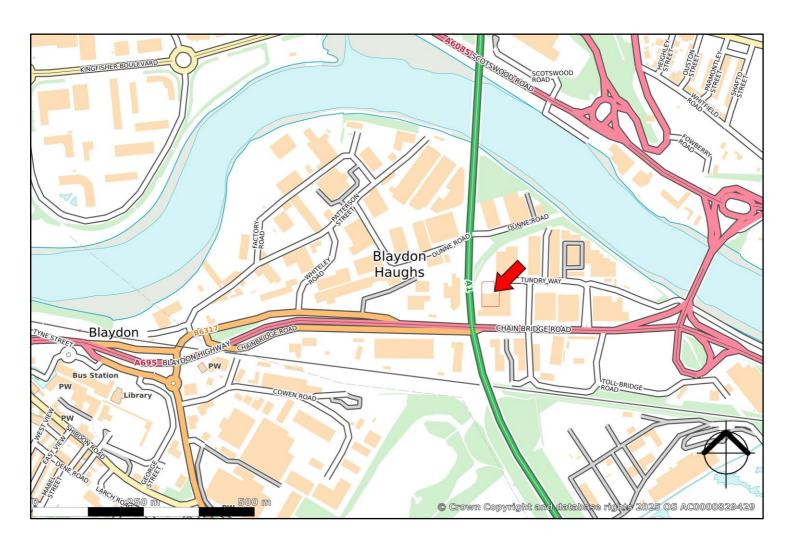
